Mayor David Wilkinson, called the meeting to order at 7:02 PM.

A roll call was taken with the following officials present: Chris Norton, Danual Priebe; also, in attendance: Allan Michelson – Solicitor, Ben Berger – Zoning Inspector, Gary Harris – Fiscal Officer and visitors Cathy Kopp, Terry Moore, Linda Gray, Marti McCord, Thomas Lenhoff and Officer Bret Haven.

Mayor Wilkinson welcomed our guests.

Organizational Meeting

Chris made a motion to appoint Marti McCord to her vacated seat, seconded by Danual. Vote; 2 ayes, 0 nays

Allan swore in Marti McCord to Village Council

Chris made a motion to appoint Thomas Lenhoff to his vacated seat, seconded by Marti. Vote; 3 ayes, 0 nays

Allan swore in Thomas Lenhoff to Village Council

Marti made a motion to appoint Terry Moore to fill the seat vacated by Ken Dibler, seconded by Danual. Vote; 4 ayes, 0 nays

Allan swore in Terry Moore to Village Council

Danual made a motion to appoint Chris Norton to President Pro Tempore of Council, seconded by Marti. Vote; 4 ayes, 0 nays

Mayor Wilkinson assigned Council Members to the various Chairs; **Finance** – Thomas and Terry, **Parks** – Marti and Terry, **Safety** – Marti, **Streets** – Chris and Danual, **Water/Sewers** – Thomas, **Zoning** – Chris and Danual – Mayor Wilkinson asked if there were any disagreements – none were offered

Danual made a motion to have Allan amend the Code of Miscellaneous Ordinances, Sections 2.4 and 4.0 of the Open Records Policy and Part D of the Purchasing Policy, seconded by Marti. Vote; 5 ayes, 0 nays

Mayor Wilkinson announced that this closes the Organizational Meeting.

REGULAR MEETING

Minutes - December 16, 2021 Regular Meeting Minutes

Marti made a motion to waive the readings and to approve as submitted the December Regular Meeting Minutes, seconded by Danual. Vote; 5 ayes, 0 nays

Council Reports:

Safety

Marti reporting:

- reported that Creston has already issued 3 citations for "running the red light" on SR 83 in the first 9 hours on the job and announced that Creston has hired a new Police Officer
- introduced Officer Bret Haven who grew up in Burbank until moving away at
 the age of 13 and Officer Haven thanked Council and indicated that he is
 looking forward to working in Burbank as assigned Cathy Kopp distributed
 a note to Officer Haven and the Mayor and Council with a citizens complaint
 about the use of e-brakes, speeding and engine revving on SR 83 Officer
 Haven asked if we have signs about no e-brakes posted and Council
 confirmed that yes, we do and Council asked him to also concentrate on
 speeding through the Village as well
- Allan confirmed that Creston is to issue citations based on Creston Ordinances that he is incorporating into Burbank's Ordinances

Finance

Thomas & Terry reporting:

➤ read the January Paid Bills and the Automatic Deductions amounting to \$9,995.66 and asked if there were any questions or any details needing to be presented - none were offered; Chris made the motion to accept these payments, seconded by Danual. Vote - 5 ayes, 0 nays.

Gary reporting:

- > confirmed that Lampion did install the final LED light in the Park directed between the two shelters and that all work is now 100% complete he asked if there are any complaints or changes needed none were offered
- confirmed that he sent out the 2021 Financial Summary Report to the Mayor and Council earlier today – he reviewed the report, asked if there were any questions or comments – none were offered
- Gary asked for "a motion authorizing him to place a Legal Ad in the newspaper notifying residents that the 2021 Financial Reports are available for review, Chris stated so moved, seconded by Danual. Vote 5 ayes, 0 nays"

Parks

Marti reporting:

confirmed that a newer flag has been installed in the Park

Mayor Wilkinson confirmed that he has contacted the Baseball Association and has a meeting scheduled for January 16th, time yet to be determined, to discuss possible baseball field improvements

Water & Sewer

Thomas had nothing to report.

Streets

Chris and Danual had nothing to report.

- Mayor Wilkinson stated that he repositioned the Stop sign at Reed Court Marti reported that the sign is hanging down again and needs to be repositioned once again
- Linda Gray reported that the Township has hired someone who is patching holes and maybe the Village could also use this person; Marti reported that there may be interest by Creston in doing road work for Burbank but it requires more discussion by her with the people involved

Zoning

Chris and Danual had nothing to report.

- o Ben had nothing to report
- o Allan reported that the issue at 141 Water Street is in the court system, that he needs to set up a meeting with Ben, the Wayne County Building Inspector and the homeowner to move it to the next level
- o Allan reported that the FEMA Grant has been awarded to the Village and he is waiting on instructions from FEMA who has to appraise the property and then enter into negotiations with the Owner to see if an agreed upon price can be arrived at
- Allan reported no progress on 111 and 124 W. Middle Street nor on 215 E. Middle Street with Zoning issues - he asked Council how he should proceed - nothing was offered at this time
- o Gary reported that he met the engineer at the culvert on E. Middle Street who did respond with recommendations one of the recommendations was to repair the storm sewer pipe on the southwest slope and to temporarily stabilize the slope using precast blocks, like those used on the Water Street culvert, and then add backfill the engineer believes the current broken storm sewer pipe has caused the majority of the erosion on the slope and may be contributing to the scour hole in the channel at the culvert inlet another recommendation was to consider doing a hydraulic study to confirm that the culvert sizing is correct Gary has the opinion that it probably met the design standards at the time the work was done Gary stated that he cannot proceed to get bids on this work as there is an issue of private property involved Allan reviewed the properties in question and

determined that Linda Gray's property adjoins the proposed work area – Linda agreed to sign-off authorizing work to proceed – Gary stated that he will contact contractors to obtain bids – Linda asked about the issues on the north side of the culvert – Gary said he was not aware of any issues and no work was planned on the north culvert discharge side

 Danual made a motion to increase the pay for the Zoning Inspector by \$60 per month effective February 1st, seconded by Terry. Vote; 5 ayes, 0 nays

New Business:

Gary reporting:

- ✓ confirmed the next Council meeting will be Thursday, February 3rd at 7:00 PM
- ✓ confirmed depositing \$0.00 for November Traffic Fines

Old Business:

Gary reporting:

- ♣ reviewed 21 Front Street and the additional repair he completed he confirmed sending the property owner a "late notice" on the invoice for these repairs completed as first invoiced in November and now asked for payment by the end of December to avoid any further action - he stated no payment has been received
- Chris made a motion to Lien the property, seconded by Marti. Vote; 5 ayes, 0 nays
- Allan confirmed issuing a request to Kimble's for either a multi-year or single year contract to replace the existing contract that expires on February 28, 2022
 he will continue working this with Kimble
