- ✓ Chris made a motion to appoint Carolyn Dibler to the open Council Seat vacated by Ben Berger, seconded by Tracy. 4 ayes, 0 nays
- ✓ Carolyn was sworn in, by Allan, as a Council member
- ✓ Chris made a motion to approve Carolyn as the President of Council, seconded by Tracy. 4 ayes, 0 nays
- ✓ Carolyn was sworn in, by Allan, as the Mayor of the Village of Burbank for 2016
- ✓ Dennis made a motion to appoint Ben Berger to fill the now vacated Council seat, seconded by Chris. 4 ayes, 0 nays
- ✓ Ben was sworn in, by Allan, as a Council member
- ✓ Dennis made a motion to approve Gary Gallion as the President of Council, seconded by Ben. 5 ayes, 0 nays
- ✓ Chris made a motion to approve updating the Rules of Council with the new Council Meeting Dates to now be the first Thursday of each month and to modify the five posting sites for Ordinances and Resolutions as now being the Village Post Office, Faith United Church, Village Hall, Burbank Parke and the Burbank Community Park, seconded by Tracy. 5 ayes, 0 nays
- ✓ Council discussed the Organization and agreed on the following: Finance Tracy and Gary, Safety – Chris and Tracy, Streets – Ben and Gary, Water/Sewer – Dennis and Jason, Parks – Dennis and Jason, Zoning – Ben and Chris

Tracy reporting:

- > Tracy read the Paid Bills and the Automatic Deductions amounting to \$2,670.38. Tracy made the motion to accept these payments, seconded by Chris. 5 ayes, 0 nays.
- ➤ Gary Gallion presenting for Fiscal Officer Gary Harris; reported that in the last 30 days we had 7 visitors to our Ohio Checkbook website, 2 were returning visitors and 5 new visitors; the Fiscal Officer reported that no one visiting the site has yet forwarded any questions which they are able to do by simply "double clicking" the payee which then has a "pop-up" screen appear and one of the options is to ask a "question" which is then sent electronically to the Fiscal Officer who will respond within a couple of days after receipt.
- ➤ Gary Gallion presenting for Fiscal Officer, Gary Harris; asked the status of the Easement needed for the Traffic Light Pole Block Grant which needs to be resolved first in order for the Village to obtain ODOT approval on the engineered drawings with time to deliver approved drawings to Wayne County Planning Dept. by 2/29/2016; per Allan this effort is in process

Dennis reporting:

- He spoke with Greg Songer, with PEP, to obtain clarification on the "open" items yet to be completed in the Parks
- Confirmed that the safety ground cover needs about 120 yards of material and 2 x 12 lumber for the border at a cost of about \$2,400 for materials only

Reported that Ben obtained someone to do the snow plowing who agreed to charge the same rates as the Village was charged last year by Nev's
